### **FCMC Safe Routes Project Overview**

The Franklin County Municipal Court became aware of the Safe Routes Program in November of 2019 through the Department of Neighborhoods. We were approached to see if we would be willing to help the Columbus Public Health Department implement their local Safe Routes Program by assisting in the litter cleanup and sign placement. The planning phase had already been completed with various community partners, the maps were laid out, logos created and the signs were being printed. What they lacked was volunteers to actually implement the plan. This was a perfect fit for a special project. The Columbus Public Health Department identified the seven target schools across the city, sent us work site requests and maps for each school, and then went with us on the first one to show us how it was done. After that we were off and running! In retrospect, I have to say, it has been one of the favorite projects our defendants have participated in. After all, who doesn't like feeling like they are making the streets safer for children?

### **General Statistics of Target Schools**

Altogether, we utilized **70** community service workers over **10** work days for a total of **300** service hours. We covered **15.9** linear miles with signs and picked up **535** pounds of trash, over a quarter of a ton plus **3** tires and **1** needle!

For the majority of the schools we picked up trash as we walked along putting out signs. The most notable exceptions to this were East Columbus Elementary School and Hamilton Stem Elementary School. At Hamilton Stem we did not attempt to pick up the trash along Hudson St because there was just too much trash for our group to be able to pick up and still get the signs put out within our allotted time period. Likewise, our attendance was down both days we were scheduled at East Columbus Elementary and the volume of trash was too much for us to be able to pick up and still get the signs out in our allotted time frame. One worker began to attempt to pick up trash, which is why we have a half a bag recorded, but we soon realized it was going to be too much.


#### LINEAR MILES BY SCHOOL




#### **VOLUMUE OF TRASH BY SCHOOL**

The Community Cleanup Crew picked up trash as we put out the Safe Routes signs. We later weighed the bags of trash before we disposed of them to have actual weights. We then compared the amount of trash between schools and the ratio of trash per mile.



The graphs below depict the statistics by school:



# TOTAL PROJECT: 300 Service Hours PROJECT SUMMARY

In Summary, The Community Cleanup Crew had no idea when we agreed to help with the Safe Routes Project last fall that the pandemic would eliminate most of the other community volunteers. Luckily, we were able to come back after our program resumed and complete the tasks. While it wasn't what was originally discussed, we feel it was still a success. Even though many of the students are attending virtual classes, the schools are still open to provide breakfasts and lunches for those students that need them as most of the target schools are located in at risk neighborhoods so this program is still as important as ever. The Franklin County Municipal Court was proud to be a part of such a worthwhile project for our communities.

Overall, we picked up 28.5 bags of trash over 10 work days equaling 535 lbs. of trash, 3 tires and 1 needle over 15.9 linear miles and put out approximately 1200 signs at 7 target elementary schools utilizing 70 community service workers for a total of 300 service hours!
